Terms of Reference of the Advisory Committee

The Advisory Committee will have an advisory role. It will offer advice / suggestions on matters relating to functioning of NCW with specific emphasis on prioritization of the Laws / Acts and Policies to be taken up for review together with suggestions regarding Grievances Redressal Mechanism. The Advisory Committee may advise the Commission on the following:

Provisions of Constitution and other laws relating to women that may be taken up for review by the Commission for making appropriate recommendations.

- Implementation of specific laws that have been enacted to provide protection to women may be taken up for review by the Commission.
- Implementation of women related policies that may be taken up for review by the Commission. ii.
- Review of grievance redressal mechanism of the Commission. iii.
- Specific areas that may be undertaken for promotional, educational research and capacity building. iv.
- Recommendations/suggestions for shaping the vision for NCW. ν.

Tenure of External Members

Ordinarily the tenure of each Member will be two years. Members would be eligible for re-nomination. The total tenure of nominated members shall not exceed four years.

Meetings of the Committee

At-lease two meetings would be held every year. 4.

Agenda of the Committee

The Agenda of the Committee will be decided by the Commission. 5.

Expenditure

- Expenditure in connection with the Constitution of Advisory Committee shall be met out of the allocation of NCW. Nominated Members will be reimbursed the cost of the travel to and fro Delhi / Venue of the meeting, local travel cost, and cost on boarding and lodging. They will also be entitled to sitting fee for attending the Committee meeting.
- The above issues with the approval of the Competent Authority. 7.
